I acknowledge that the Marty's Place Ruff Mudder Canine Obstacle Challenge is an athletic event that is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to participants, volunteers, spectators, event organizers, and lack of hydration. I hereby assume all of the risks of participating in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, and know of no medical or other condition that would prevent me from participating in the event and have not been advised otherwise by a qualified medical person. In the event of injury, I agree to pay any and all medical and other costs in their entirety.

I acknowledge that this Waiver and Release Form form will be used by the event holders, sponsors and organizers, and that it will govern my actions as well as responsibilities at said events.

In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my pets, my executors, administrators, heirs, next of kin, successors, and assigns as follows; (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me including my traveling to and from this event, the following entities or persons: Marty's Place Senior Dog Sanctuary, Jersey Longhorn, LLC, event sponsors, event vendors, event organizers, event volunteers, and agents; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all claims made as a result of participation in this event, whether caused by negligence of releases or otherwise.



I further release Marty's Place from any liability for harm caused by other participants in this event and agree to defend, indemnify and hold harmless Marty's Place in any suit arising out of any act, omission, negligent or willful misconduct on the part of another participant.

I hereby consent to medical treatment that may be deemed advisable in the event of injury, accident and or illness during this event.
